## RULES OF THE GAME

# ARTICLE 1: ACCESS TO THE SITE DEFINITIONS

For the purposes of these rules, the expressions below shall have the following meanings:

## ARTICLE 7: CONDITIONS FOR REIMBURSEMENT OF PARTICIPATION FEES

In accordance with the provisions of Article L. 121-36 of the Consumer Code, access to the website and participation in the game offered therein are entirely free and unrestricted, so that the costs of connecting to the site, incurred by the participant, will be reimbursed according to the terms below:

- Only one refund per month and per household (same name, same postal address)
- Participant residing in one of the countries deliverable by the site
